# REPORT OF THE SUPERINTENDENT OF PUBLIC WORKS

#### ISLAND OF OAHU

## MAINTENANCE OF GOVERNMENT PROPERTY

The maintenance and repair of the various Territorial buildings have been performed along the usual lines, such as repairs to the woodwork, plumbing, roofs, repainting, etc. The utmost economy has been practised and only such repairs have been made as were deemed absolutely necessary.

The following contracts were awarded during the last period and incomplete on June 30, 1932, the details of which were completely described in the report ending June 30, 1931, and were completed during this period.

The furnishing and installing of Laundry and Boiler Equipment at Waimano Home was awarded to Durant-Irvine Company, Limited, for the sum of \$18,090.63.

## ISLAND OF HAWAII

For constructing a road through the village of Kamaili-mauka. Puna, Hawaii, was awarded to the County of Hawaii for the sum of \$10,698.95.

## ISLAND OF MOLOKAI

For the construction of a Gymnasium and Community Hall at Hoolehua for the Hawaiian Homes Commission was awarded to Mr. Charles W. Bridges for the sum of \$17,000.00.

For the construction of a General Warehouse at Kalaupapa for the Board of Leper Hospitals and Settlement was awarded to Mr. C. W. Winstedt for the sum of \$7,350.00.

For the construction of a Visitor's Cottage at Kalaupapa for the Board of Leper Hospitals and Settlement was awarded to Mr. W. S. Ching for the sum of \$5,179.00.

#### ISLAND OF MAUI

For the construction of the Wailuku Territorial Office Building at Wailuku was awarded to Jonah Kumalae for the sum of \$33,674.64.

For the construction of the Haleakala Road was awarded to E. C. Mellor for the sum of \$506,479.88.

The following contracts were awarded during this period:

#### ISLAND OF OAHU

A contract was awarded to the Universal Motor Company, Limited, for the sum of \$1,489.00 for one new Fordson Tractor and Mowing Machine.

Plans and specifications were prepared and a contract awarded to Walker and Olund, Limited, for the sum of \$34,934.75 for the construction of a Disturbed Patients' Ward Building at the Territorial Hospital, Kaneohe. The main building is 168' 4" long, 27' 4" wide, with a wing 36' 0" by 39' 0", with walls of reinforced concrete and concrete hollow tile, concrete floors, steel roof trusses with a tile roof; all lavatories have tile floors and walls. This work has been satisfactorily completed.

#### ISLAND OF KAUAI

Plans and specifications were prepared and a contract awarded to the Kauai Construction Company, Limited, for the sum of \$5,800.00 for grading and planting grass on the Wailua Airport, which work has been satisfactorily completed.

#### ISLAND OF MAUI

A contract was awarded to the Valley Isle Motors, Limited, for the sum of \$1,519.00 for furnishing one new Fordson Tractor Mowing Machine.

Plans and specifications were prepared and a contract awarded to Mr. K. Hondo for the sum of \$1,940.00 for making alterations and additions to the basement in the new Wailuku Territorial Office Building. The work was performed to provide quarters for the Bureau of Agriculture and Forestry and consisted in cutting openings in the basement walls and installing windows, con-
