## AIRPORT ZONING BOARD Special Meeting Tuesday, March 10, 1953

A special meeting of the Airport Zoning Board was held in the Office of City Planning Commission, City Hall Annex, on Tuesday, March 10, 1953.

MINUTES: Minutes of the meeting held on Feburary 27, 1953, were approved as circulated.

LETTER FROM MATS: Mr. Martin presented a letter from Headquarters, Pacific Division, Military Air Transport Service, outlining comments and recommendations made by the Commanding Officer of the 1500th Air Base Wing.

> Mr. Martin observed that their regulations were more stringent. For example, width of the approach zone at the end of the clear zone for runways at Hickam Air Force Base would be 1,500 feet in accordance with paragraph 8d, AFR 86-3, whereas our regulations would require

Question was raised as to whether or not our regulations would apply to military property or vice-versa. Mr. Andrew reminded the Board of the fact that it was agreed in previous meetings that we were not going to enter into military properties. It was mentioned that even though their regulations do not agree with the proposed airport zoning regulations our standards are maintained in so far as it pertains only to properties outside of military airports.

Mr. Pietsch suggested that the Airport Zoning Board should acknowledge and thank them for their recommendations. It was so moved, seconded and carried.

SURVEY MAPS: Mr. Martin, on being asked regarding the progress of survey maps, stated that much of this work must be held in abeyance to determine the final form of the Airport Zoning Regulations. Mr. Houghtailing asked that he summarize briefly the information gathered so far. According to Mr. Martin's report, Hilo is almost completely mapped, so is Honolulu and Kahului. Kona and Lihue will require complete photography and mapping.

The whole cost was roughly estimated at \$3,200.00.

He stated that photos should be made of the Kona area because that would be a controversial area. Mr. Martin also strongly recommended photos of the Lihue Airport Area. Moved, seconded, and carried that the board authorize Mr. Martin to go ahead with the project on the basis of his report.

Question was raised regarding Molokai. Mr. Martin reported that we do not have much information on it, and that it may not be important. Mr. Andrew commented that the possibility of anyone contemplating the building of any structure is quite remote.

Mr. Martin stated that if an area is not heavily populated, a topographical map should be sufficient. Chairman Houghtailing stated that the matter will be left with Mr. Martin until he could report further on it.

RE: INTERPRETATION OF ACT: Chairman Houghtailing asked if Mr. Sharpless was contacted with regard to the question on the authority of HAC and the AZB. Mr. Martin stated that Mr. Sharpless was detained by a previous Minutes, March 10, 1953 -- 2

engagement and that he might not be able to attend the board meeting. The matter was deferred.

ACKNOWLEDGMENT OF LETTERS: Mr. Martin reported that he had acknowledged the letters of recommendations received on the proposed airport regulations as instructed at the previous meeting.

HEARING NOTICE: A draft of the hearing notice was read. There was some discussion on the inclusion of Hickam Air Field. The first paragraph was reworded.

NOTICE IS HEREBY GIVEN of a public hearing to be held by the Airport Zoning Board of the Territory of Hawaii at the Hawaii Aeronautics Commission Conference Room, Overseas Terminal Building, Honolulu International Airport, on April 1, 1953, at 2:30 p.m. or as soon thereafter as those interested may be heard to consider the proposed regulations.

Preliminary copies of the Airport Zoning Regulations are on file in the office of the Airport Manager, Honolulu International Airport, and are open to the public for inspection during office hours.

All protests to the regulations should be filed in writing before the date of the public hearing, or presented in person at the time of the public hearing.

For your further information, sub-hearings will be held at later dates on the principal outer islands. Appropriate notices will be published.
