# Director's Message



t is my pleasure to submit the Hawaii State Department of Transportation's annual report for the fiscal year ending June 30, 2004.

Our department has been very productive this year, launching a number of major projects to address Hawaii's future land, sea and air transportation needs while also diligently tending to present-day problems.

Airport security remains a top priority in the post 9/11 world. Our Airports Division continues to work closely with the Transportation Security Administration to increase security measures while maintaining efficiency at the islands' eleven airports. At the Honolulu International Airport, a new, six-lane security checkpoint is currently under construction. Scheduled for completion in FY 2005, Security Checkpoint 3 will provide the international terminal an additional high-volume passenger screening area.

Our Harbors Division continues preparations for numerous pier improvements statewide which will help to enhance the growth of Hawaii's tourism industry. Neighbor island harbor master plans for Kahului Harbor, Nawiliwili Harbor and Port Allen Harbor are also being updated to the year 2025.

Highway improvement projects are also underway in various phases statewide to assist the growing number of motorists on state roads. On Oahu, these projects include the widening of the H-1 Freeway Waimalu Viaduct, the widening of Fort Weaver Road in Ewa Beach and the construction of the North-South Road in Kapolei. On Kauai, traffic congestion is also being improved with such projects as the Kapaa Temporary Bypass Road, the Puhi Temporary Bypass Road and contra-flow operations between Hanamaulu and Wailua, among others. The widening of Mokulele Highway from two to four lanes from Kuihelani Highway to Pillani Highway is just one of many projects also in progress to help to ease traffic on Maui. Plans for the Big Island include the widening of the Queen Kaahumanu Highway to four lanes from Henry Street to the Kealakehe Parkway and numerous other projects (detailed within) to help keep commuters on the move.

The Hawaii State Department of Transportation continues its commitment to safe and efficient modes of transportation in our Aloha State.

# Airports Division

he statewide airport system consists of eleven airports serving commercial airlines and general aviation flights, and four airports serving general aviation flights only. In Fiscal Year (FY) 2004, statewide airports handled 31,052,561 passengers, a 2.7 percent increase compared to the previous year.

Security issues remain a primary concern in this post 9/11 era. The Transportation Security Administration (TSA) and the Airports Division are planning the reconfiguration of the passenger screening checkpoints at Honolulu International Airport. In April 2004, the TSA approved the layout of six permanent

lanes at Security Checkpoint 3, which is currently under construction. The new Security Checkpoint, scheduled for completion in FY 2005, will create a more efficient security screening area for travelers. There are also plans to reconfigure the baggage screening area in the ticket lobbies to meet new security requirements.

The Airports Division ended fiscal year 2004 with slight increases in total passenger activity (2.3%) and deplaning international passengers (1.7%), over FY 2003. However, aircraft operations, landed weights, and revenue passenger landings decreased by 4.6%, 2.5% and 5.6%, respectively, compared to FY 2003.

Aircraft operations were lower due to Aloha Airlines, Inc. and Hawaiian Airlines, Inc. significantly reducing inter-island flights and carriers from Japan reducing flight schedules. Although passenger enplanements increased, landed weights decreased due to some airlines phasing out heavier aircraft (such as DC-10s and 747s) and replacing them with smaller aircraft (such as Boeing 767-300s).

To encourage more direct flights from Honolulu, the DOT implemented an Air Carrier Service Incentive Program in FY 2004 to attract new non-stop flight service to and from the Honolulu International Airport. The incentive program which granted landing fee credits, provided airline carriers an opportunity to promote Hawaii as a more profitable destination. Delta Airlines, Inc. added flights from Cincinnati to Honolulu and Atlanta to Honolulu, and China Airlines, Ltd. added flights from Taipei to Honolulu. The airlines are continuing to reduce costs by utilizing lighter, more fuel efficient aircraft and reducing the frequency of flights to increase passenger load factors. As a result, landing fees, net of aviation fuel tax credits, decreased by \$1.1 million or 3.1% compared to FY 2003.

The majority of operating revenues at the Airports Division is activity-based and directly related to the number of passengers and the level of aircraft operations.



Honolulu International Airport

The financial results for FY 2004 were significantly affected by a decrease in concession revenue and interest income and the continued impact from the events of September 11, 2001. As a result, net assets decreased by \$17.8 million for FY 2004, compared to an increase of \$1.5 million for FY 2003.

Concession revenues decreased by \$17.1 million primarily due to the withdrawal and settlement agreement with the DFS Group L.P., which lowered the minimal annual guarantee rent. Non-operating View of Administrative Tower and Pagoda Garden at revenues decreased by \$11.9 million mainly due to the decrease in interest income as a result of the

> nominal rate on cash investments. As a result, operating revenues amounted to \$214.9 million, \$22.1 million less than FY 2003.

> To address the large anticipated revenue shortfall, the Airports Division implemented a financial management plan to monitor monthly expenditures. The Airports Division restricted Legislative appropriations by \$16 million or 10% for planned expenditures. Quarterly meetings were held to review the financial performance of the airports and to forecast revenue and expenditures for personnel, special maintenance, and capital projects for the fol-District airport managers were lowing quarter. given budgetary financial data along with financial forecasts, granting them the flexibility to oper

ate their airports within financial constraints. To attract new direct flights from destinations not served by some carriers, the Airports Division created a new airline incentive for Honolulu International Airport – a first for the State of Hawaii. The incentive provided the airline station managers an opportunity to promote Hawaii as a profitable destination.

Other sources of revenues such as landing fees and aeronautical/non-aeronautical rentals appear to have stabilized.

The events of September 11, 2001 have had a significant adverse impact on security and insurance costs. Post-9/11 costs for security and insurance have increased by an average of \$10.8 million and \$1.7 million per year, respectively.

During FY 2004, the Airports Division regained its eligibility for federal discretionary grants. The Airports will use the federal grants to replace and maintain equipment and facilities at the various airports while using only 5% to 25% in State matching monies.

Beginning October 1, 2004, Passenger Facility Charges (PFC) were implemented, creating another source of funding for FAA-approved airport capital projects. The Division will impose a \$3.00 PFC for all overseas and international passengers boarding at Honolulu International Airport, Kahului Airport, Kona International Airport at Keahole and Lihue Airport. The PFC is projected to generate approximately \$18 million per year.

The Airports Division issued \$80.9 million in Airports System Revenue Bonds, Refunding Series of 2003 to refund \$80.3 million of Refunding Series of 1993 bonds still outstanding. The Refunding Series of 1993 bond carried a fixed rate of 6.05% to 6.45% while the Refunding Series of 2003 had an initial rate of 2% per annum through June 30, 2004, and a fixed weekly rate thereafter. In January 2005, the outstanding balance of \$69.3 million of the Series of 2003 will be redeemed, resulting in a reduction in the annual debt service requirement for FY 2006. All these factors, including qualifying for additional sources of funding from federal discretionary grants, implementing the PFC to fund certain airport improvement projects, converting from higher

variable rate bonds to lower rate bonds, reducing expenditures via budget restrictions, and instituting financial performance reviews, contributed to the upgrade of the outlook for Hawaii's airports (from negative to stable) by the major bond rating agencies (Standard & Poor's Corporation and Moody's Investors Service). The future financial outlook for the Airports Division remains optimistic and healthy.

Honolulu International Airport continues to be the State's busiest airport with an annual passenger traffic count of 18,877,076, a slight decrease of 1.0% in FY 2004 compared to FY 2003. Work has been completed on the strengthening of the "Wiki Wiki" bus infrastructure and on improvements to public restrooms in the main terminal and concourses. Construction is on-going for the Phase II improvements to the Overseas Terminal. This project will renovate the terminal by improving high profile concession spaces and creating a new security checkpoint.

**Kahului Airport** is the second busiest airport in the State, with 5,436,946 passengers in FY 2004, a slight increase of 0.9% compared to FY 2003. Construction started on Phase 1a of ticket lobby improvements to create a more efficient lobby area and construct additional counter and baggage handling spaces. This should enable the airport to better accommodate mainland flights.

Kahului Airport has been the beneficiary of the U.S. visa policy that permits Canadian passengers on direct flights to obtain pre-clearance from immigration and customs.

Traffic at **Kona International Airport at Keahole** increased 1.2% to 2,601,508 in FY 2004 over the previous year, making Kona International Airport at Keahole the third busiest airport in the State. Construction was recently completed on fixed based operator lots and the supporting infrastructure. This project was designed to address the high demand for general aviation facilities.

Lihue Airport is the fourth busiest airport in the State, with 2,522,191 passengers in FY 2004, a slight increase of 0.1% compared to Fiscal Year 2003. At Lihue Airport, construction is on-going for Phase II of the general aviation site preparation project. When completed, this project will create a general aviation apron for future development and additional revenue.

Hilo International Airport traffic decreased to 1,184,171 passengers in FY 2004. At Hilo International Airport, construction was recently completed on the terminal roof replacement project. Also completed was a noise attenuation project at Keaukaha Elementary School, which should enable the students and facility at Keaukaha Elementary to work in a quieter environment.

## Harbors Division

awaii's system of commercial harbors consists of 10 harbors on six islands. The system plays a vital role in the State's economy as Hawaii imports about 80 percent of what it consumes, of which, approximately 99 percent enters the state through the commercial harbor system.

In Fiscal Year (FY) 2004, commercial harbor facilities accommodated 1,322,370 cruise ship passengers compared to 1,638,856 in FY 2003. The drop in FY 2004 was primarily due to a reduction in passenger ships by Norwegian Cruise Lines (NCL).

Harbor master plans provide an overview of Hawaii's commercial harbor system, facilities, operations, growth projections and projected needs.

The harbor master plans for Kahului Harbor (Kahului Harbor Commercial Harbor 2025 Master Plan) and Nawiliwili and Port Allen Harbors (Kauai Commercial Harbors 2025 Master Plan) are in the process of being updated.

There is also an ongoing joint Federal-State effort to assess the feasibility of navigational improvements at Kawaihae and Nawiliwili Harbors.

Security projects remain a high priority with the Harbors Division. These projects include the perimeter fencing, barricades, bomb blast abatement, and video monitoring. The Harbors Division was successful in securing federal funds to offset some of the expense of these improvements. The majority of funding, however, has come from the Harbors Special Fund.

#### Honolulu Harbor

**Honolulu Harbor** is the hub of the state harbor system and most of the State's cargo passes through Honolulu.

The harbor accommodated 352,881 cruise ship passengers during FY 2004 compared to 441,176 during FY 2003.

In order to meet the increased demand for passenger terminal space, the Harbors Division will be constructing a new cruise ship terminal at Pier 2, Hono-

lulu Harbor. The terminal will be large enough to accommodate the 965-foot "state-of-the-art" cruise ships that are currently docking in Hawaii. Construction for the terminal is scheduled to begin in April 2005 and should be substantially completed by the end of 2005, when the third Hawaii home ported cruise ship is expected to begin service.

To ensure that the operational capabilities of the harbor are maintained, \$3 million has been encumbered for special maintenance projects. Major special maintenance projects undertaken during FY 2004 included repairs to pier structures; repaving of container yards; repairs to water, sewer and electrical service; renovation and repair of buildings, including roofing and repainting; improving restroom facilities; installing enhancements for harbor security; and making building modifications for ADA compliance.

#### Kalaeloa Barbers Point Harbor

Kalaeloa Barbers Point Harbor is the second busiest harbor in the State system. To improve harbor capacity there is a major joint Federal/State planning project underway to study the feasibility of deepening Kalaeloa Barbers Point Harbor. This project will deepen the turning basin and widen and deepen the entrance channel to the harbor.

To ensure that the operational capabilities of the harbor are maintained, \$54,000 was encumbered

for special maintenance projects. One of the major special maintenance projects undertaken during FY 2004 included waterline repairs.

#### Kewalo Basin

\$300,000 was encumbered in FY 2004 for special maintenance projects for repairs. Improvements were made to the electrical system and the harbor office was modified to install an emergency exit.

#### Kahului Harbor

**Kahului Harbor** is the third busiest harbor in the state system in terms of traffic and the busiest of the neighbor island harbors.

In FY 2004, Kahului Harbor accommodated 228,799 cruise ship passengers over FY 2003's 241,530 passengers.

A total of \$350,000 was encumbered for several major special maintenance projects for FY 2004. Some of the major special maintenance projects undertaken included pier structure repairs, container yard paving, and the repair and upgrade of buildings, restrooms, and utility facilities. Funds were also expended to ensure compliance with U.S. Coast Guard environmental regulations.

#### Kaunakakai Harbor

\$190,000 was encumbered in FY 2004 for a special maintenance project to repair the pier deck, maintain the fendering system and maintain the causeway at **Kaunakakai Harbor**.

#### Hilo Harbor

**Hilo Harbor** is the Big Island's busiest port and is second only to Honolulu as a port of call for cruise vessels. In FY 2004, Hilo Harbor accommodated 372,418 cruise ship passengers, compared to 487,325 the previous year.

To ensure that the operational capabilities of the harbor are maintained, \$510,000 was encumbered for special maintenance projects. Major special maintenance projects undertaken during FY 2004

included pier structure repairs; building and electrical system repairs; building modifications for ADA compliance; and harbor security enhancements. Funds were also used to ensure compliance with the U.S. Coast Guard environmental regulations.

#### Kawaihae Harbor

\$125,000 was obligated for special maintenance projects at **Kawaihae Harbor** including pier and building structure repairs.

#### Nawiliwili Harbor

In FY 2004, **Nawiliwili Harbor** accommodated 368,272 cruise ship passengers, compared to 468,825 the previous year.

\$464,000 was encumbered in FY 2003 for special maintenance projects, which included pier and building structure repairs; building modifications for ADA compliance; and harbor security enhancements. Funds were also used to ensure compliance with U.S. Coast Guard environmental regulations.

#### Port Allen Harbor

**Port Allen Harbor** is located on the south end of Kauai approximately 11 miles from both Nawiliwili Harbor and Lihue Airport.

\$154,000 was encumbered in FY 2004 for special maintenance projects to cover the repair and upgrade of the existing cargo landing shed.

## Kaumalapau Harbor

The State's newest harbor is **Kaumalapau Harbor** on the island of Lanai. This harbor is located on the southwest coast of Lanai and is the island's sole commercial harbor. There is a major project underway, overseen by the U.S. Army Corps of Engineers, to modify and repair the existing breakwater. This project is needed to reduce wave action in the harbor, thereby increasing harbor safety and usability. The U.S. Army Corps of Engineers awarded the construction contract and project work began this summer.

# Highways Division

The Highways Division manages approximately 2,470 lane miles of highways on six islands. The Division continues to improve safety and increase capacity on the state highways to the extent feasible with the available resources and staff.

Statewide, efforts to involve all segments of the public in highway planning will be intensified this year. DOT intends to host two rounds of nine neighbor island public meetings to gather input to aid in the development of the Fiscal Year (FY) 2006-2008 Statewide Transportation Improvement Program (06 – 08 STIP). To better inform, educate and involve the public, the first series of meetings will be to introduce and gather comments about an unconstrained 06 – 08 STIP. A second round of meetings will be held to report back on how the Department went about constraining the 06 – 08 STIP based on input received during the earlier public meetings.

On Oahu, the Highways Division will bid Phase-1A of the North-South Road in Ewa for the first segment between the Kapolei Parkway and Interstate H-1 Freeway to help ease congestion along Fort Weaver Road and to provide access for future developments in the area in early 2005. The division is also widening Fort Weaver Road from four to six lanes between Farrington Highway and Aawa Drive to improve traffic flow. Preparation of designbuild plans to widen this stretch of Fort Weaver Road is underway.

A contract for the \$55 million westbound widening of the Interstate H-1 Freeway between Kaonohi Street and the Pearl City Off-Ramp was awarded in June 2004 and construction is expected to be completed in June 2006.

Planning studies continue on ways to improve traffic flow along the Interstate H-1 Freeway. Included are improvements to the Waiawa Interchange and eastbound improvements between the Waiau and Halawa Interchanges. In urban Honolulu, the division is continuing a demonstration study to improve the westbound freeway at the Lunalilo Street On-Ramp and Vineyard Boulevard Off-Ramp. A final decision on making the diversion permanent is pending the completion of community surveys, traffic and travel time counts, and other data

analysis. The division is also studying the feasibility of other projects to improve eastbound traffic flow along the H-1 Freeway between Middle Street and the University area. This includes the possibility of installing another eastbound lane between the Kalihi Interchange and the Vineyard Off-Ramp, and designing the addition of another lane between the Liliha Street On-Ramp and the Pali Highway Off-Ramp.

The Halawa-Luluku Interpretive Development Office (HLID) under the Office of Hawaiian Affairs (OHA), in cooperation with the Highways Division, is continuing community outreach and planning work related to the H-3 Interpretive Development Plan (IDP). The IDP will address the interpretation, maintenance, and appropriate treatment of various archaeological sites and artifacts that were impacted by the construction of the Interstate H-3 Freeway in the Halawa and Haiku Valleys. HLID recently conducted a series of public meetings and is currently working on the Strategic Plan to develop general themes and to provide recommendations for the IDP.

The first phase of the Freeway Management System (FMS) for the Interstate H-1, H-2 Freeways and Moanalua Freeway is currently in the design stage. The FMS will be implemented in six phases and create a freeway incident management program and traveler information system; vehicle detectors, closed-circuit TV and dynamic message signs will be installed and joined, together the City & County of Honolulu Traffic Surveillance System and portions of the Interstate H-3 Tunnel Surveillance System. Deployment of freeway service patrols is scheduled to begin in 2005 and development of a business plan for implementing Level 1 of the Federal Motor Carrier Safety Administration Commercial Vehicle Information Systems and Networks is in-progress. These projects, through the Oahu Metropolitan Planning Organization's (OMPO) Intelligent Transportation Systems (ITS) Task Force, were coordinated with OMPO's effort to finalize the Oahu ITS Architecture Plan, ITS Integration Strategy Plan and Concept of Operations Plan. OMPO's effort establishes a framework for planning, designing, implementing, integrating, and deploying ITS systems covering highways on Oahu.

On the island of Hawaii, several bridge seismic retrofit projects are either ongoing or have been completed. The widening of the Queen Kaahumanu Highway to four lanes from Henry Street to the Kealakehe Parkway will be bid as a design/build contract in February 2005. Planning studies are continuing on the Waimea Bypass and have started on the Kawaihae Bypass. A smaller planning study to improve the Waiaka Stream Bridge and approaches at the Kawaihae Road/Kohala Mountain Road intersection continues. The project will help to increase safety through the area.

The \$21 million Kealakaha Stream Bridge replacement project, using segmental bridge construction, will be advertised with the bid opening scheduled for January 2005.

The ADA compliance project for the Honokaa-Waipio Road and Akoni Pule Highway in the towns

of Honokaa, Kapaau, and Hawi will be bid towards the end of 2004.

Twenty-one miles of the Queen Kaahumanu Highway from Hapuna to Kona Coast State Park were resurfaced. Intersection improvements at the Route 11/Huina Road, Route 11/Hualalai Road, Route 19/Kona Police Access Road, and Route 270/Puukohola Heiau National Historical Site intersections were also completed.

On Maui, the design and construction of Puunene Avenue and Mokulele Highway widening from two to four lanes from Kuihelani Highway to Piilani Highway continues. The project is being constructed in 5 phases. Design for Phase IC, Maui Humane Society to Vicinity of Kolaloa Bridge, is nearly completed and bidding was scheduled for mid-2005. Construction for Phase IB, Vicinity of Kolaloa Bridge to Vicinity of Kealia Pond Driveway will begin June 2005. Design for Phase 1A, Vicinity of Kealia Pond Driveway to Piilani Highway is being completed and bidding is scheduled for late 2005.

Construction for the first phase of Haleakala Highway widening between Hana Highway and North Fire Break Road was completed. Construction of the second phase is expected to begin in 2006 and be completed in 2007, at which time the morning contra-flow will likely be discontinued.

Bid opening for the first phase of Lahainaluna Road to Keawe Street Extension is scheduled for March 2005.

In Paia, DOT is studying ways to improve traffic flow along Hana Highway. An interim improvement to provide an alternative route for right turning traffic from Hana Highway onto Baldwin Avenue will be put out to bid upon completion of the Maui County's Environmental Assessment in 2005. The alternative route will be used on weekdays during afternoon peak traffic hours and is a cooperative effort between the state, Maui County and Alexan-

der & Baldwin Properties.

The Final Environmental Impact Statement and Record of Decision were completed for the Kihei-Upcountry Maui Highway project and procurement for design services has started.

The first phase of the Hana Highway Rockfall Mitigation project at Mile Post 11 on Route 360 went out to bid in June 2004 and construction is

scheduled to begin in April 2005. Design for the second phase at Mile Post 19 is ongoing and is expected to be completed in 2006.

On the island of Molokai, work on the Kamehameha V Highway, Emergency Replacement of Kawaikapu Bridge, is scheduled for completion in 2007.

On Kauai, the "Kapaa Temporary Bypass" and the "Puhi Temporary Bypass" routes, along with the contra-flow operations between Hanamaulu and Wailua continue to temporarily relieve traffic con-

gestion in their respective areas. Construction for the extension of the temporary bypass from Olehana Road to Kuhio Highway will begin in early 2005.

The Kapaa Traffic Circulation Study to evaluate the traffic circulation in the Waipouli-Kapaa area was completed and interim improvements are being considered. The permanent Kapaa Bypass and the Kaumualii Highway widening projects are expected to contribute significantly to reducing Kauai's traffic congestion problems. A planning study for this undertaking is ongoing with an anticipated completion date in 2006. Design for the first phase for the widening of Kaumualii Highway, from Lihue to Kipu Road is scheduled for completion in 2006.

#### Oahu District

On Oahu, approximately \$47 million of roadway resurfacing and rehabilitation projects were completed during the fiscal year. These included: Rehabilitation of Makakilo Interchange; Kamehameha Highway Pavement Preservation from Avocado Street to Kilani Avenue; Kamehameha Highway Resurfacing from Kaneohe Bay Drive to Kahiko Street; Interstate Route H-1 Resurfacing from Punchbowl Off-Ramp to Kapiolani Interchange; Nimitz Highway Rehabilitation from Sumner Street to Queen Street; and Mokapu Road Stability Improvements, Vicinity of Mikiola Drive to Kahinani Place.

Approximately \$16 million of capacity improvement projects were completed. Such projects included: furnishing barriers for the Zipper Lane extension from Radford Drive to Nimitz Highway; Widening the Punahou Street Off-Ramp; Sand Island Access Road Intersection Improvements at Road No. 2; Fort Weaver Road Widening from Laulaunui Street to Hanakahi Street; and Wilikina Drive Intersection Improvements at McNair Gate.

Safety improvement projects totaling \$11 million were completed, including the Installation of emergency telephones on H-2 from Waiawa Interchange to Wilikina Drive; Kalanianaole Highway rock scaling and rockfall mitigation at Makapuu; Moanalua Freeway Lighting Improvements from

Aiea Interchange to the Middle Street Tunnel; Pali Highway Safety Improvements from School Street to Waokanaka Drive; and Kalanianaole Highway Landslide Repair at Castle Junction.

Projects to enhance roadways and highways totaling \$7.3 million were completed. These include: Kamehameha Highway Sidewalk Improvements from Meheula Parkway to Kuahelani Avenue; Waialae Shoulder Improvements for Bicycle Lanes from Kealaolu Avenue to Kalanianaole Highway and from 17th Avenue to 21st Avenue; Farrington Highway Landscaping from Kamehameha Highway to Fort Weaver Road; and the Pedestrian Facilities and ADA Compliance at Various Locations – Phase II.

About \$7.6 million of projects to improve drainage and reduce flooding were completed, including the Kamehameha Highway Drainage Improvements in the Vicinity of Kahuku Hospital and Replacement of Kii Bridge; and the Kamehameha Highway Drainage Improvements in the Vicinity of Wajau Power Plant.

Approximately \$10 million of miscellaneous roadway improvement are ongoing, including the Farrington Highway Improvements from Nanakuli Avenue to Nanakuli Stream and from Lualei Place to Princess Kahanu Avenue; Interstate Route H-2 Installation of Highway Lighting from Leilehua Interchange to Waiawa Interchange; Kaneohe Bay Drive Improvements from Puohala Street to Kawa Bridge; and the Ala Moana Traffic Signal Modernization Entrance to Ala Moana Shopping Center.

The \$55 million Waimalu Viaduct Widening and Seismic Retrofit for the Austin Bishop Grade Separation where a 6<sup>th</sup> westbound lane from the Kaonohi Overpass to the Pearl City Off-ramp is ongoing.

Various rehabilitation and resurfacing projects such as the Interstate Route H-1 Palailai Interchange Reconstruction; Kamehameha Highway Resurfacing from Waiahole Valley Road to Crouching Lion Inn; Likelike Highway Resurfacing from Emmeline Place to Wilson Tunnel; Wilson Tunnel Improvements; Moanalua Freeway Resurfacing from Halawa Interchange to Kahauiki Interchange; and Kalanianaole Highway Resurfacing from Ainakoa

Work is ongoing for the \$7.3 million Kamehameha Highway Replacement of Halawa Stream Bridge.

#### Hawaii District

Construction of the \$6.4 million widening and resurfacing of Keaau-Pahoa Road, Paradise Drive to Pahoa was substantially completed. The project resurfaced the roadway and constructed paved shoulders and improvements at five intersections along the Keaau-Pahoa Road. Also, a waterline for the Hawaiian Homelands Makuu Farmlots Subdivision was installed.

The seismic retrofit projects for several bridges in the Hamakua, North Hilo and South Hilo Districts are continuing. There are eight contracts totaling \$15 million that are in progress or have been completed.

Construction totaling \$11.6 million to remove leadbased paint at the Kapue, Kolekole, Paheehee and Hakalau Bridges was completed in 2003.

Construction for the \$17.5 million Kupapaulua Bridge widening was completed in late 2004. Approximately \$10.2 million of highway resurfacing projects in North Hilo, Hamakua, North Kohala, South Kohala, Puna, North Kona, and South Kona Districts, and \$5.9 million of guardrail and shoulder improvement projects in South Kohala and Kau were under construction or completed in this year.

\$1.9 million in intersection improvements on Queen Kaahumanu Highway at Waikoloa Beach Drive and Waikoloa Road were completed, including the installation of traffic signal systems and highway lightings at both intersections.

Also completed was the \$1 million bike lane project on Kamehameha Avenue between Kanoelehua Avenue and the Hilo Bayfront Park and the \$599,000 Queen Kaahumanu Highway drainage improvement project in the Vicinity of Mauna Kea Beach Hotel.

Work has started on intersection improvements at the Volcano Road/Huina Road and the Kawaihae Road/Puukohola Heiau National Historic Site intersections.

#### Maui District

Approximately \$22 million of highway infrastructure improvements to relieve congestion were completed, including; installing two-left lanes on Waiehu Beach Road, Makaala Drive to lao Stream Bridge and pavement marking and striping on Piilani Highway and North Kihei Road; Piilani Highway Interim Widening, Mokulele Highway to Kilohana Drive; Honoapiilani Highway Widening, Kuihelani Highway to North Kihei Road; Traffic Operational Improvements at Various Locations; Kuihelani Highway Widening, Honoapiilani Highway to Puunene Avenue; Puunene Avenue Widening, Kuihelani Highway to Hansen Road; Mokulele Highway Widening, Hansen Road to Vicinity of Cane Haul Road Crossing; and the Honoapiilani Highway Traffic Signal Modernization, Kaanapali towards Lahaina.

Various roadway resurfacing, repairs and maintenance projects such as the Honoapiilani Highway Resurfacing, Vicinity of McGregor Point to Olowalu; Kaumalapau Highway Resurfacing, Vicinity of Lanai Airport towards Lanai City; Kaumalapau Highway Resurfacing, Vicinity of Lanai Airport Road towards Miki Road; Kamehameha Highway V Resurfacing, Kamalo to Pukoo; Main Street Resurfacing, Central Avenue to Kaahumanu Avenue and Kaahumanu Avenue Resurfacing, Main Street to Hobron Avenue; and Dairy Road Resurfacing, Keolani Place to Kuihelani Highway totaling \$7.2 million were completed.

Projects to repair and maintain roadways such as the Hana Highway Emergency Roadway Repairs at Various Locations; Route 360 Hana Highway Repairs and Maintenance, Phase 2; Honoapiilani Highway Guardrail and Shoulder Improvements, High Street to Puamana; Kahekili Highway Repairs and Maintenance; Kekaulike Avenue Repairs and Maintenance at Various Locations totaling to \$5.1 million were completed.

\$2.7 million worth of miscellaneous roadway improvement projects were completed. These included: Kaahumanu Avenue Drainage Improvements, South Wakea Avenue to Kahului Beach Road; Hana Highway Drainage Improvements, Hobron Avenue and Dairy Road; and the Route 360

Hana Highway Improvements, Mile Post 4.20 to Mile Post 23.70.

Roadway enhancement and beautification projects such as the Honoapiilani Highway Bypass Landscaping, Kuialua Street and Hookahua Place; Honoapiilani Highway Bikeway Improvements, Shaw Street to Maalaea Harbor and Kekaulike Avenue Bikeway Improvements, Kula Highway to Haleakala Highway; and the Kaahumanu Avenue Landscape Improvements Phase 1, Lono Avenue to Hana Highway were completed in FY 2004.

Construction of safety improvement projects remains a priority and several projects were completed. These included: Haleakala Highway Guardrail and Shoulder Improvements, Haliimaile Road to Kula Highway and Kahekili Highway Guardrail and Shoulder Improvements at Haihee Bridge; Haleakala Highway Widening, Phase 1; Kalae Highway Guardrail and Shoulder Improvements, Maunaloa Highway to Kalaupapa Lookout Parking Lot; and the Honoapiilani Highway Guardrail and Shoulder Improvements, High Street to Puamana.

Two bridge replacement projects along Route 36 totaling \$18 were completed. Hana Highway Replacement of Uaoa Bridge and Approaches and the Hana Highway Replacement of Kaupakulua Bridge and Approaches were completed and opened to traffic.



Work to repair the hillside along Kalanianaole Highway at Castle Junction began in January 2004 and is expected to be completed by December 2004. The landslide caused by the heavy rains in the summer of 2003 left one Honolulu-bound lane completely closed for several months.

Ongoing projects to relieve congestion on state highways include design for the \$35 million Honoapiilani Highway Realignment, Phase 1A, Future Keawe Street Extension to Lahainaluna Road.

Other various ongoing projects are: Haleakala Crater Road Repairs and Maintenance at Various Locations; Kula Highway Repairs and Maintenance at Various Locations; Kamehameha V Highway Replacement of Kawaikapu Bridge; Maui District Baseyard Repairs and Maintenance of Buildings and Grounds; and the Molokai Baseyard Improvements.

#### Kauai District

Approximately \$3.7 million of resurfacing projects such as the Kaumualii Highway Resurfacing, Vicinity of Mahaikona Bridge to Waimea Canyon Drive; Nawiliwili Road Resurfacing, Kaumualii Highway to Waapa Road; and the Kuhio Highway Resurfacing, Hardy Street to Kuene Road were completed.

Roadway and highway improvement projects totaling \$6.5 million were completed. These include: Kaumualii Highway Drainage Improvements, Vicinity of Mile Post 22; Kapule Highway Miscellaneous Improvements, Vicinity of Ahukini Road to Kuhio Highway; Kuhio Highway Intersection Improvements at South Leho Drive; Kaumualii Highway Intersection Improvements at Koloa Road; and the Kaumualii Highway Drainage Improvements, Vicinity of Huleia Stream Bridge and the Hanapepe Valley Scenic Lookout.

The \$1.8 million project to repair and replace deteriorated metal members on the Hanalei Bridge on Kuhio Highway was recently completed.

Approximately \$8 million of ongoing construction projects include: Kuhio Highway Shoulder Improvements, Haena to Princeville; Kuhio Highway, Waikaea Stream Bridge Widening; Kaumualii Highway Guardrail and Shoulder Improvements, Omao to Hanapepe; and the Kuhio Highway Resurfacing, Vicinity of Kealia.
