

Dear Governor King:

I am submitting the annual report for the Department of Public Works for the fiscal year ending June 30, 1954.

New highway contracts awarded during the year totaled \$4,672,851.63. They improved mileage on all major islands. However, our highway deficiencies are still estimated at more than \$50,000,000. With our present income (\$5,000,000 a year in Federal-aid and earmarked territorial revenues), we cannot build fast enough to keep up with the needs of traffic.

The year brought Hawaii a chance to increase its annual volume of highway construction. A new Federal law makes available to the Territory an additional \$700,000 per year in Federal-aid for highways, providing Hawaii can match this sum. The Governor plans to name a tax advisory committee on highways to study means of obtaining additional territorial matching money.

New non-highway contracts awarded during the year totaled \$1,554,995.73. The biggest contract in this category (\$490,272) was for new dormitories at Waimano Home at Pearl City, Oahu. Construction of a five-unit armory at Hilo, Hawaii, got underway. A territorial office building on Molokai and new Kapaa Branch Library on Kauai were other major projects which were started in fiscal year 1954.

Chief airport contract granted during the year was for construction of paved areas at the freight terminal building at new General Lyman Field on Hawaii. Biggest contract let for architectural or engineering services went to Theodore A. Vierra for architectural services for the new terminal building at Honolulu International Airport.

The number of contracts for architectural and engineering services for public works projects supervised by the Building Division increased from two in 1952-53 fiscal year to 10 in 1953-54, and the dollar volume went up from \$16,400 to \$73,758.

These increases reflect the fact that the Department of Public Works is, on this date, on the threshold of a greatly stepped-up program of general public works construction. As a means of easing unemployment, the Governor's Construction Priorities Committee has scheduled for 1954-55 the major portion of public works projects authorized by the 1953 Legislature.

Prospects are that the dollar volume of non-highway public works projects started in 1954-55 by the superintendent of public works will top the record-breaking total for the year ending June 30, 1949, and will set a new high.

For the sake of efficiency, there were several administrative changes. The superintendent created the position of deputy territorial highway engineer. He will serve as secondranking highway officer in the department in matters affecting the Federal-aid highway system. The assistant superintendent of public works will dedicate his entire time to non-highway matters. The fiscal officer has been designated as the administrative assistant to the superintendent of public works, and has received broader powers.

The department has combined into one three filing systems which formerly were separate. The parking problem around the public buildings has been receiving intensive study. The department superintendent has alerted key division heads to the need for constant management improvement and has asked them to recommend any changes which might lead to more efficient operation.

# General Public Works

The Department of Public Works awarded new contracts totaling \$1,554,995.73. for public works of a non-highway nature.

This total included \$152,504.62 in contracts to be supervised by the Airport Division, and \$1,402,491.11 worth of projects under supervision of the Building Division. The total represented a drop of \$180,449 from the previous fiscal year. Non-highway contracts have been declining in dollar volume since fiscal year 1949, when they hit the record high of \$8,091,220.

However, the number of contracts for architectural and engineering services for the Building Division increased from two in 1952-53 fiscal year to 10 in 1953-54, and the dollar volume went up from \$16,400 to \$73,758. These increases reflect the fact that the Building Division is preparing for a greatly stepped-up program of general public works construction. To ease unemployment, the Governor's Construction Priorities Committee has scheduled for 1954-55 the major portion of the large public works program authorized by the 1953 Legislature.

Biggest public works contract of a non-highway nature in fiscal year 1953 was for Waimano Home's newdormitories. The contract amount was \$490,727. Construction of a five-unit armory at Hilo, Hawaii, began. A territorial office building on Molokai and Kauai's new Kapaa branch library were other major projects started.

Projects under construction in fiscal year 1953 under supervision of the Building Division are listed below. Airport projects are discussed on the following page.

Cost figures given for completed jobs represent total payment to the contractor. Other figures are original award amounts, including extras.

# The Airport Division

The Airport Division supervised 12 construction projects, totaling \$992, 373. 78 during the fiscal year ending June 30, 1954. They advanced airport development on four islands.

The Territorial Department of Public Works is planning and construction agent for the Hawaii Aeronautics Commission.

Until the 1953-54 fiscal year, the Airport Division was chiefly concerned with runways, roads and lighting within airports, while airport structures were the design and construction responsibility of the Building Division. During fiscal year 1954, the Airport Division assumed primary responsibility for all design and construction relating to airports.

The Airport Division devoted considerable time to plans for the new Honolulu International Airport terminal. Architect Theodore H. Vierra is expected to complete plans for the terminal building in December 1954, under a \$63,000 contract.

Airport projects under construction in the 1954 fiscal year are listed below. Figures for completed contracts represent the total payment to the contractor. Other amounts listed are original contract award figures, including extras.

General Lyman Airport — Passenger terminal. Single - and multi-storied building of wood frame and reinforced concrete. Completed August 25, 1953. \$298, 274.65.

Air conditioning of control tower cab. Completed August 25, 1953. \$4,493.

Tee hangar. Steel frame and corrugated iron building. Completed November 15, 1953. \$19,152.65.

Construction of paved areas at the passenger terminal. Completed January 8, 1954. \$192, 813.16.

Installation of high intensity lighting system for Runway 8-26. Completed February 4, 1954. \$153,076.92

Construction of paved areas at freight terminal building. 99 per cent completed. \$71,237.50.

Honolulu International Airport — Installation of medium intensity lighting for Runway 4L and taxiways. Completed September 16, 1953. \$131,798.53.

Construction of addition to Hawaiian Airlines terminal building. Completed June 1, 1954. \$8,384.

Kahului Airport — Purchasing of runway lighting equipment. Delivered October 13, 1953. \$24,649.97.

Resurfacing of runway. Completed August 28, 1953. \$9,267.12

Kamuela Airport — Passenger and freight terminal building. One-story, wood frame building. Completed October 7, 1953. \$58,988.92.

Molokai Airport — Drainage ditches. Completed September 22, 1953, \$20, 237.36.
